

## Eastern Illinois University Petition for Reinstatement

1. Fill out this petition only if you have been dismissed twice or more for low grades, keeping in mind that you must remain out of school for at least one semester before being eligible to apply for reinstatement. *A summer term does not count as a semester out of school.*
2. If you owe the University money or have any other hold on your record, your petition will be returned to you. It is up to you to check your PAWS account or check with the Records Office at (217) 581-3511 to make sure that you do not have a hold. Petitions will not go to the committee until any hold is cleared; this must be done before the published deadline date.
3. Your petition and all supporting materials must be completed, signed, and returned by the deadline date, not just postmarked by that date. (If you are submitting the petition via email, a signature is not required.)
  - If you are petitioning to return to EIU in the **Fall** semester, your materials are due by **4 pm on the 3<sup>rd</sup> Monday in June.**
  - If you are petitioning to return to EIU in the **Spring** semester, your materials are due by **4 pm on the 3<sup>rd</sup> Monday in October.**
4. If you have attended a college or university since being dismissed from EIU, you must send an official transcript (which includes your name and student identification number) to the Office of the Registrar and Enrollment Management if you are reinstated. ***You must have a composite grade point average of at least 2.00 on a 4.00 scale for all courses attempted at institutions other than EIU.*** If the transcripts are not received or show that you do not meet this condition, you will not be re-admitted to Eastern.

For students currently enrolled at another college/university at the time of applying for readmission to EIU, the *Required Statement in Lieu of an Official Transcript* (see below) will be accepted until a final transcript can be sent. Final transcripts are due in the Office of the Registrar by the tenth-class day or a hold will be placed on your record. **FALSIFICATION MEANS DISMISSAL.**

1. You **MUST** type your answers. **Petitions that are not typed will NOT be accepted.**
2. Fill out the form, print it, and mail it to the address below. If necessary, you may type your responses on a separate document and mail it (along with a copy of the form) to the address below.
3. **Answer each question, A through G. Your responses should be well written, thorough, and clear. Provide specific examples wherever possible; proofread your work carefully.**
4. Before sending in your petition, be sure to complete the bottom of page 7. Fill in the date, signature, and mark "I give permission" or "I do not give permission" for the petition and academic information to be reviewed by the student member of the Committee on Reinstatement. (Again, if you are submitting the petition via email, a signature is not required.)
5. If you wish, you may ask your former advisor at EIU, current instructors, etc. to send a statement concerning your qualifications.

**NOTE:** Shortly after the meeting date, you will be notified by letter of the Committee's decision. If you do not receive a letter, you believe that all your materials were turned in by the deadline, and you have no holds on your record, feel free to contact the Provost's Office at (217) 581-2023.
