# III. Approved Executive Actions

 November 14, 2003 memorandum from Dean Rohn, CEPS, requesting executive action to revise the mission statement for the M.S. degree in Counseling. Revise current statement

From: "The Department of Counseling and Student Development offers a Masters of Science in College Student Affairs. The program meets the requirements for the Council for the Advancement of Standards in Higher Education (CASHE). Degree completion leads to comprehensive preparation for careers in college student affairs."

To: "The M. S. in Counseling provides dynamic curricula for students interested in obtaining certification as School ounselors or licensure as Licensed Professional Counselors (LPC) and Licensed Clinical Professional Counselors (LCPC). Students choose a concentration either in Community or School Counseling, both fully accredited by the Council for Accreditation of Counseling and Related Educational Programs (CACREP). These concentrations lead to a terminal degree and prepare students for employment either as School Counselors within K-12 school systems or as Community Counselors within mental health agencies,

health care facilities, employee assistance programs (EAP), or human service agencies. Students who complete the program are eligible to pursue Ph.D./Ed.D. studies in Counselor Education, Counseling Psychology, Clinical Psychology, and other related fields or to pursue specialized training in Marriage and Family Counseling, Play Therapy, or Private Practice."

This executive action is effective Fall, 2003.

- 2. November 10, 2003 memorandum from Associate Dean Lynch, requesting executive action to revise the English M.A. Program.
  - 1. The current ENG 5000 (Studies in Old and Middle English Literature) will be re-numbered ENG 5001 in order to accommodate the addition of the new ENG 5000 (Introduction to Methods and Issues in English Studies).
  - 2. The title of ENG 5061 will be changed from "Special Topics in Language and Literature" to "Special Topics in Literature and Literary Theory," in order to distinguish it from the new course ENG 5901, "Studies in Language, Linguistics, and Literacy."

ART 5500. Current Trends in Art Education. (3-0-3) S. (Current Trends) A seminar course designed to present graduate art education students with current trends, theories, concepts, and strategies for teaching art.

## 4. <u>03-43</u> New Course Proposal 5505 ART

Dr. Gene Harrison and Mr. Glen Hild presented the proposal and answered questions of the council. The motion passed unanimously with minor language changes.

This item was approved, effective Fall 2005.

ART 5505. Assessment in Art Education. (3-0-3) F. (Assessment in Art) A seminar course that will focus on assessment strategies for art educations. Elective for the Master of Arts Degree in Art with the Art Education Option.

### 5. **03-44** New Course Proposal 5510 ART

Dr. Gene Harrison and Mr. Glen Hild presented the proposal and answered questions of the council. The motion passed unanimously with minor language changes.

This item was approved, effective Fall 2006.

# ART 5510. Curriculum Design in Art Education. (3-0-3) F. (Curricula Design) A seminar course designed to present theories, strategies, and experiences in designing art curricula. Topics for class discussion include: contemporary approaches to teaching art, current research about the characteristics of elementary and secondary students, and existing designs for scope and sequence for art curricula. Elective for the Master of Arts Degree in Art with the Art Education Option.

### 6. **03-45** New Course Proposal 5970 ART

Dr. Gene Harrison and Mr. Glen Hild presented the proposal and answered questions of the council. The motion passed unanimously with minor language changes.

This item was approved, effective Summer 2004.

ART 5970. Independent Study in Art Education. (Arr.-Arr.-1 to 6). S. (Ind Study Art Ed) Advanced studies in research leading to the completion of the research project/paper in art education. May be repeated for a maximum of six semester hours of credit.

ART 5800. Research Methods in Art Education. (3-0-3). S. (Research Methods) A seminar course that will focus on research methods for art education. Required course for the Master of Arts Degree in Art with the Art Education Option.

### School of Business MBA Honor Code

To do otherwise, constitutes plagiarism, which is using the work of another without giving proper credit.
