V. Items Acted On

1. <u>03-47A</u> Incomplete Grade Policy Graduate and <u>03-47B</u> Incomplete Grade Policy Graduate Form

Dr. Noll presented the proposal and answered questions of the council. The motion passed unanimously.

This revision (See Attachment A), along with the proposed form (See Attachment B), were approved, effective Spring 2004.

The proposal has been forwarded to the President for approval.

2. 03-37 New Course Proposal 5940 SPC

SPC 5940. Creative Thesis. (Arr. - Arr. 3-6). F,S, SU. (Creative Thesis). Students engage in a capstone project with an applied communication focus that reflects a comprehensive understanding of communication theory and research. Students may take no more than nine hours from a combination of SPC 5920, 5940, 5950, & 5997.

Dr. Miller presented the proposal and answered questions of the council. The motion passed unanimously.

This new course proposal was approved, effective Spring, 2004.

3. 03-39 School of Business MBA Honor Code

Dr. Noll presented the proposal and answered questions of the council. After discussion, Dr. Noll stated she would return the proposal with language changes requested by the council at the November 18, 2003 meeting.

4. 03-40, M.A. in Gerontology, Program Revision

The courses for the degree must total at least 30 semester hours for programs including the thesis and at least 32 semester hours for program without thesis. All students enrolled in this program must satisfy the basic 18-19 sh core requirements listed below. In addition to the core requirements, 12-14 sh of graduate credit electives are to be selected by the student with prior approval of the advisor. Students without the appropriate preparation, may be required to take additional graduate or undergraduate course work as determined by the Gerontology Program Committee.

SOC 4800 Sociological Aspects of Gerontology 3 s.h.

PSY 5540 Psychological Processes in the Aged 3 s.h.

FCS 5846 Administration of Human Services Programs 3 s.h.

PED 5225 Physical Activity and Aging 3s.h.

FCS 5900 Research Methods in FCS 3 s.h.

FCS 5980 Internship 3-4 s.h.

Total 18-19 s.h.

Dr. James Painter presented the proposal and answered questions for the council. The council requested the title of FCS 5900 should be consistent with the graduate catalog, Research Methods in FCS. The motion passed unanimously with the stipulation of a change in language.

This revision was approved, effective Fall, 2004 with the stipulation that the language changes would be made.

1. 03-34 Proposed Revision to Math Education Program

The proposal was revised to reflect the language changes and was returned to the council on November 4, 2003.

This revision was approved, effective Summer 2004

Degree: Master of Arts Major: Mathematics

Option: Mathematics Education-Elementary/Middle School

Admission Requirements:

To be eligible for degree candidacy, applicants must meet all the requirements for admission to the Graduate School (see "Admission to Graduate Degree and Certificate Programs"). In addition, applicants must submit evidence of successful completion of accredited teacher education programs from Eastern Illinois University or other equally accredited institutions. Applicants must also

possess a valid teaching certificate. Two years teaching experience is highly recommended. <u>Note</u>: This is not a certificate granting program. Those interested in earning an endorsement in middle level education should take MLE 5110 and MLE 5150.

Degree Requirements:

The requirements for the Master of Arts Degree for the Mathematic Education - Elementary/Middle School option are 32 semester hours (30 hours if thesis is written) selected and approved by the Mathematics and Computer Science Department from the following:

At least eight semester hours selected from the Basic courses in Education. See catalog or contact Mathematics Education graduate coordinator for current list.

At least eight semester hours chosen from Mathematics 4800, 5635, and 5810;

At least six semester hours of courses selected from Mathematics 4750-5335;

Three semester hours of Mathematics 5400, three semester hours of Mathematics 5410, and four semester hours of Independent Study.
