# I. President Perry

#### IV. Executive Actions

- 1. Dean Diane Hoadley, LCBAS, requests the following be approved by executive action from Graduate Business Studies to be effective Fall 2008:
  - a. <u>COS 4820 Sociotechnical Design.</u> Change Strategies in Organizations Justification: The present title was descriptive of change strategies in organizations practiced when this course was initially developed in the early 1990s. The term "sociotechnical design" is far less frequently used as a descriptor of change processes now and the new title reflects a more generic, easily recognizable title. The title change will help students better understand the intent of this course.
  - b. COS 4870 Developing Critical Thinking in the Workplace. Coaching and Mentoring in the Workplace

**Justification:** The title change specifies that the development strategies used to enhance critical thinking and problem solving are coaching and mentoring strategies rather than educational or training ones. The title change thus conveys more accurately to students the skills they will use in order to develop critical thinking.

After discussing the two executive actions, COS 4820 and COS 4870, the question was asked whether or not the course description should be changed since the course title was being changed. Dean Augustine stated that he would check on this and therefore the decision to approve the executive actions was postponed.

1. <u>07-27</u>, ENG 4765, Professional Editing (New Course Proposal)

Dr. Hanlon presented the proposal and answered questions of the council.

The proposal was approved unanimously with an effective date of Fall 2008.

**ENG 4765. Professional Editing. (3-0-3) F.** Advanced practice and theory in professional editing, including copyediting and comprehensive editing. Focus on working effectively with writers, publishers, and audiences. Discussion of the production process and the role of technology in editing and information design.

2. <u>07-28</u>, ENG 5020, Graduate Workshop in Creative Writing (New Course Proposal) Dr. Hanlon presented the proposal and answered questions of the council.

The proposal was approved unanimously with an effective date of Spring 2008.

ENG 5020. Graduate Workshop in Creative Writing. (3-0-3) S, on demand. Workshop in Creative Writing. An advanced workshop in which writers create and revise long-term writing projects. Each semester the course will focus on a different genre (fiction, creative nonfiction, poetry, or drama).

- 3. 07-17, First Choice Review- Gerontology
  Dr. Elder gave a report from the First Choice Review Board stating that Gerontology will
  work toward evidence of sustained achievement and ask for a review again in the future, but
  will not receive First Choice designation at this time.
- 4. <u>07-25</u>, CSD 5930, Foundation of Clinical Counseling (Revised Course Proposal)

Dean Augustine reported that Dr. Roberts asked this item be postponed until the November 6, 2007 meeting.

5. <u>07-26</u>, Concentration Title Change (Community Counseling concentration to Clinical Counseling)

Dean Augustine reported that Dr. Roberts asked that this item be postponed until the November 6, 2007 meeting.

 ATAC – Dean Augustine reported that he has been appointed to be part of the ATAC Fee Subcommittee. He did encourage the CGS members to attend the ATAC meetings scheduled for this Fall where they will be discussing technology planning for software that could help advance graduate education.

for review in Spring 2008. He felt that the meeting went pretty well and feels things are moving in a good direction.
