07-10, HIS 4870, The Two Koreas (New Course Proposal)
Dr. Elder presented the proposal and answered questions of the council.

The proposal was approved unanimously effective Spring 2008.

HIS 4870. The Two Koreas. (3-0-3) On Demand. This course examines the historical context in which North and South Korea emerged and continued as a divided nation during the twentieth century. Particular attention will be paid to the most important political, economic, and socio-cultural phenomena in the divergence of the images and reality of North and South Korea before, during, and after the national division of 1945. No prerequisites.

2. <u>07-11</u>, HIS 4880, Modern Japan: From Samurai to Freeters (New Course Proposal) Dr. Elder presented the proposal and answered questions of the council.

The proposal was approved unanimously effective Fall 2008.

HIS 4880. Modern Japan: From Samurai to Freeters. (3-0-3) On Demand. Modern Japan. This course examines the historical transformation of Japan from Tokugawa times to the present. Particular attention will be given to the most influential political, economics, and social phenomena that the people have faced in the making of modern Japan since the nineteenth century. No prerequisites.

3. <u>07-12</u>, HIS 4980, The Vietnam War: An American and Vietnamese Ordeal (New Course Proposal)

Dr. Elder presented the proposal and answered questions of the council.

The proposal was approved unanimously effective Spring 2008.

HIS 4980. The Vietnam War: An American and Vietnamese Ordeal. (3-0-3) On Demand. The Vietnam War. A reading, discussion, and writing course focusing on the Vietnam War (Second Indochinese War, 1965-1975) from an American, Vietnamese, and international perspective. No prerequisites.
