V. First Hub Update

Working with Marcom to conduct a social media blast, as well as creating material to hand out. EIU 1111 classes will be held adjacent to the hub. Peer promotion and updated maps and signs are planned.

VI. CORE Bylaws

Discussion focused on mission and vision alignment, roles and responsibilities, meeting frequency, voting procedures, membership size, subcommittees, and communication/transparency. Preference for monthly meetings to have a designated day/time, but not specified in the bylaws. Quorum proposed at 13 members. Voting is to be used for formal proposals. Membership concerns include representation and liaison roles (Advancement, Registrar, and Student Accounts). Downsizing was also mentioned. Subcommittees to be formed based on emergent issues. Subcommittees that were proposed to be permanent subcommittees, like Accessibility and Transfer Retention.

VII. EIU 2919 Redesign

EIU 2919 is getting redesigned. Amber Webb is working closely with Kim Ervin from the FDIC to revamp the material and make it more engaging. The Academic Support Center will be opening up this fall semester. It is located in McAfee 1611. Features flexible seating and will have a standing desk. Open Monday-Thursday 8 am to 7 pm and Fridays from 8 am to 4:30 pm. The center will be staffed by certified peer educators and tutors.
