# 1. 14-71, Gateway Program Admission Policy (Revised Policy).

Dr. Davenport presented the proposal and answered questions of the council.

Dr. Reid moved and Dr. Gronnvoll seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, effective immediately.

# **Gateway Program**

Students who do not meet regular admission requirements may be considered for admission to the Gateway Program. Admission is considered for beginning freshmen for the Fall Semester of each academic year. Maintaining a culturally diverse student body, including adequate representation of students in the total student body, is an educational goal of the University. The University measures annual progress toward its ultimate goal by increases in the percentage of underrepresented students in its student body. Underrepresented students include those who will be the first in their immediate family to obtain a college degree.

The University will consider applications from candidates who have an ACT composite standard score of at least 14 and who have a high school cumulative GPA of at least "C" (2.00 on a 4.00 scale) based on six or more semesters. This differential test score standard is intended to take account of the cultural bias associated with standard admission tests. Applicants must also meet the high school subject requirements specified for all entering freshmen. In addition to completing a program admission application, applicants must submit a writing sample and three letters of recommendation from high school teachers and/or counselors (2) two recommendations [Gateway Recommendation Forms] from academic instructors, of which one may be from a guidance counselor which provide evidence of the applicant's character, motivation, ability to overcome economic and educational disadvantage, work experience, and other relevant factors. An interview may be required and high school attendance patterns will be considered. Gateway is a limited enrollment program and meeting minimum academic guidelines does not guarantee admission.

# 2. 14-77, ACT Requirement for the Gateway Program Admission (Revised Requirement).

Dr. Davenport presented the proposal and answered questions of the council.

Dr. Reid moved and Ms. Duffin seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, effective immediately.

# Gateway Program

Applicants must also meet the high school subject requirements specified for all entering freshmen. In addition to completing a program admission application, applicants must submit a writing sample and (2) two recommendations [Gateway Recommendation Forms] from academic instructors, of which one may be from a guidance counselor which provide evidence of the applicant's character, motivation, ability to overcome economic and educational disadvantage, work experience, and other relevant factors. An interview may be required and high school attendance patterns will be considered. Gateway is a limited enrollment program and meeting minimum academic guidelines does not guarantee admission.

#### 3. 14-78, BIO 4850 (replaces BIO 5372), Wildlife Techniques (New Course).

Dr. Deppe, Dr. Gordon and Dr. Bulla presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Ms. English moved and Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Fall 2014, pending course fee approval. This course will replace BIO 5372. Note: CGS approved this course at its meeting on April 29, 2014.

**BIO 4850. Wildlife Techniques. (2-3-3) F.** Instruction in current field, lab and analytical techniques in wildlife biology. This will include: population and biodiversity estimation, capture and marking, behavioral observations, age estimation, condition assessment, biotelemetry, and habitat assessment. BIO 5372 and BIO 3960 are equivalent courses. Students will not be allowed to earn credit in BIO 4850 if they already have received credit for BIO 5372 or BIO 3960. Grade and credit hours for this course will be removed if student already has credit for those courses. Prerequisites: Junior-level standing and "C" or better in BIO 3950 or BIO 3800 or permission of instructor. BIO 4750 recommended. WI

# 4. 14-79, AET 4763, Rapid Prototyping Technology (New Course).

Dr. Boonsuk presented the proposal and answered questions of the council. The council requested a revision to the proposal.

Dr. Anthony moved and Dr. Reid seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revision, was approved, effective Spring 2015, pending CGS and course fee approval.

**AET 4763. Rapid Prototyping Technology. (2-2-3) On Demand.** Introduction to rapid prototyping (RP) processes and basic principles of rapid prototyping technology. This course will include a study of engineering design, product development processes, design for manufacturing, and reverse engineering technology. Prerequisite: AET 2043.

# 5. 14-80, HST 3110, First Aid/CPR AED for the Health and Fitness Professional (New Course).

Dr. Bates and Dr. Rhoads presented the proposal and answered questions of the council. In addition, Dr. Bates distributed copies of an updated version of the proposal and identified the following information which had been added to the proposal:

- 1. Assignments/activities were added to Part II, 2.
- 2. A lab components column was added to the table under the course outline.

The council requested a minor revision to the proposal.

Ms. English moved and Dr. Gronnvoll seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revision, was approved, effective Fall 2014, pending course fee approval.

HST 3110. First Aid/CPR AED for the Health and Fitness Professional. (3-2-4) FA/CPR/AED HIth/Fitness Prof. This course includes theory and practical application of comprehensive First Aid, CPR, AED and emergency response skills. It helps students recognize and respond appropriately to cardiac, breathing, and first aid emergencies, as well as prepare them for natural and man-made disasters. Upon successful completion of the course, students will receive certification in First Aid/CPR/AED from a nationally recognized agency. Students receiving credit for HST 3120 will not be allowed to receive credit for this course. This course is restricted to Kinesiology & Sports Studies majors in Exercise Science Option and Health Studies majors and minors.

BIO 4820 - Spatial Analysis for Environmental Sciences. (3-3-4) F. An introduction to how spatial data are synthesized and interpreted in the environmental sciences. # **Film Studies Minor**

The interdisciplinary Film Studies minor is devoted to the study of cinema history, theory, criticism and production. The minor is comprised of three required film-centered courses (Film Studies 3759G, "History of Cinema", Communication Studies 3530, "Film Communication," and English 3504, "Film and Literature" English 4904, "Studies in Film.") and a core list of courses with film-specific content. Up to two courses in the film studies minor can be double counted in a student's major. Coursework may also include Honors Program course equivalents. Existing prerequisites for all courses must be satisfied. Including required courses, students may count no more than two courses in their major area(s).
