1. September 20, 2002 request for Executive Action from the College of Sciences Curriculum Committee:

SOC major (B.A.) – Delete the admission requirement to the major with a corresponding change in the catalog statement as follows: “In order to be certified for graduation with a major in sociology, a student must achieve a CGPA of at least 2.0 in the core courses in the major used to satisfy graduation requirements. In order to be certified for graduation with a minor in sociology, a student must achieve a CGPA of at least 2.0 in the core courses in the minor used to satisfy graduation requirements.”
