October 27, 2005

The October 27, 2005 meeting of the Council on Academic Affairs was held at 2:02 p.m. in Booth Library Conference Room 4440.

I. Approval of the October 20, 2005 Minutes.

The minutes of October 20, 2005 were approved as written.

1. Demonstration of the CAA electronic meeting discussion board.
Today Mr. Danny Harvey, CATS, was unable to give the demonstration of the new CAA electronic meeting discussion board. Therefore, the demonstration will be rescheduled for a future CAA meeting.

VI. Items Acted Upon: (Note: The agenda order was revised.)

1. **05-49, ART 3440, Art for Teachers in the Elementary Grades (New Course)**
Mr. Hild and Dr. Belleville presented the proposal and answered questions of the council.

Dr. Carwell moved and Dr. French seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, effective Fall 2006, **pending approval of the course fee by the President's Council.** *NOTE: Once the course fee is approved ART 3440 will replace ART 2440.*

ART 3440. Art for Teachers in the Elementary Grades. (2-2-2) F., S. Elem Art Methods. A methods course for elementary education students in the teaching of art education to children from grades K-6. The course will identify art content, art media, and instructional pedagogy appropriate for teaching art at the elementary level. Prerequisites: Enrollment in Elementary Education, Middle Level Education, or Special Education. Preference given to students with university approval to take Teacher Education courses.

Ms. Dilworth entered the meeting at 2:20 p.m.

2. 05-48, Discussion of the University Mission Statement

Provost Lord explained why President Hencken requested the campus community to undertake a discussion of the University's mission statement. The council members discussed and debated whether or not the statement should be revised. They also discussed ideas for improving it. Dr. Reid will compile a summary of today's discussion and present it to the council members for further discussion at the November 10 CAA meeting.

VII. Other:

1. Dr. Reid announced that the Opens Meetings Act was recently amended by Illinois legislation. She summarized the revisions. The council members agreed that the group was abiding by the rules for open meetings.
2. Dr. Bower distributed a memorandum to the council recommending revisions to the grade appeals policy (IGP 45). She provided an explanation for the request.

The proposal will be placed on the next agenda as an item for the council to add to the agenda. Also, the Council on Graduate Studies (CGS) must be involved in discussions. Therefore, the proposal will be sent to Dean Augustine to add to the CGS agenda and for discussions between the CAA and CGS executive committees.

3. Dr. Reid indicated that the General Education proposals will be acted upon at either the December 1 or December 8, 2005 meetings.
