Each April since 1987, the National Council on Alcohol and Drug Dependence, Inc. (NCADD) has sponsored Alcohol Awareness Month. This month gives an opportunity to update your knowledge about alcohol use disorder (AUD) and the adverse impact of alcohol misuse on health and society. Alcohol Awareness Month increases public awareness and understanding, reduces stigma and encourages local communities to focus on alcoholism and alcohol-related issues.

## Fast Facts About Alcohol Did you know that...

- 75% of esophageal cancers are attributable to chronic excessive alcohol consumption.
- Nearly 50% of cancers of the mouth, pharynx and larynx are associated with heavy drinking
- As many as 35% of heavy drinkers develop alcoholic hepatitis.
- There are more deaths and disabilities each year in the U.S. from substance abuse than from any other cause.
